

## Declaration of Application for Annual Practising Certificate 申請週年執業證明書的聲明

Pursuant to section 16(2) of the Supplementary Medical Professions Ordinance (Cap 359), an annual practising certificate will be issued to you **subject to the payment of the prescribed fee for the issue of a practising certificate and your submission of a declaration** stating whether or not you have been convicted in Hong Kong or elsewhere of any offence punishable with imprisonment since the date of the last declaration made by you for the purposes of your registration as a radiographer or application for a practising certificate.

Please complete and return this declaration form to this Office if you wish to apply for an annual practising certificate for the year of 2011/2012. Please also make arrangement to pay the fee for the practising certificate by PPS, ATM, Internet Banking, PayThruPost, Cheque or in person. For details of the payment methods, please refer to the Demand Note.
