

**Application for Restoration of Name  
to the Register of Medical Laboratory Technologists  
under section 10(5) of the Supplementary Medical Professions Ordinance**

Pursuant to section 10(5) of the Supplementary Medical Professions Ordinance, a person whose name has been removed from the register under section 10(4) of the Ordinance may apply to the Medical Laboratory Technologists Board for the restoration of his or her name to the register. The Board may, subject to any conditions it considers appropriate, approve or decline the application. Upon the Board's approval and the applicant's payment of the prescribed fee, his or her name will be restored accordingly.

Applicants should complete the application form as attached, accompanied by a statutory declaration made before a Commissioner for Oaths or Notary Public as to the truthfulness of the contents of the application form and whether you have practised the profession in Hong Kong after your name has been removed from the Register. A list of offices in the Department of Health which provide statutory declaration service is enclosed.
