

FULL REGISTRATION UNDER ALLIED HEALTH PROFESSIONS ORDINANCE  
(Chapter 359)

It is hereby notified that in accordance with regulation 4(1) of the Medical Laboratory Technologists (Registration and Disciplinary Procedure) Regulations, Chapter 359A, Laws of Hong Kong, the Supplementary Medical Professions Council ("the Council") specifies the following qualifications required for registration as a medical laboratory technologist with full registration:—

- (1) a Diploma in Medical Laboratory Science issued by the Hong Kong Polytechnic;
- (2) an Ordinary Certificate in Medical Laboratory Technology issued by the Department of Extra-mural Studies of the University of Hong Kong;
- (3) a Certificate of Competency in Medical Laboratory Technology issued by the Medical and Health Department of the Hong Kong Government prior to 1982;
- (4) a Higher Certificate in Medical Laboratory Technology issued by the Department of Extra-mural Studies of the University of Hong Kong;
- (5) a Higher Diploma in Medical Laboratory Science issued by the Hong Kong Polytechnic or The Hong Kong Polytechnic University;
- (6) a Bachelor of Science degree in Biomedical Science awarded by the Hong Kong Polytechnic or The Hong Kong Polytechnic University;
- (7) a Bachelor of Science (Honours) degree in Medical Laboratory Science awarded by The Hong Kong Polytechnic University;
- (8) a Bachelor of Science degree in Medical Laboratory Science awarded by The Hong Kong Polytechnic University;
- (9) a degree of Bachelor of Science (Honours) in Medical Laboratory Science awarded by Tung Wah College;
- (10) a degree of Bachelor of Medical Science (Honours) Major in Medical Laboratory Science awarded by Tung Wah College; or
- (11) a certificate from the Medical Laboratory Technologists Board ("the Board") that he has passed an examination relating to the profession of a medical laboratory technologist conducted under section 15A of the Ordinance for the purposes of section 12(1)(a) of the Ordinance.

It is also hereby notified that in accordance with regulation 4(2) of the Medical Laboratory Technologists (Registration and Disciplinary Procedure) Regulations, Chapter 359A, Laws of Hong Kong, the Council specifies the following qualification and experience required for registration as a medical laboratory technologist with full registration to be entered in Part I or Part II of the register:—

The Secretary must enter the name of a medical laboratory technologist:—

- (a) who holds a qualification referred as (4), (5), (6), (7), (8), (9) or (10) of this Notice with:—
  - (i) experience of not less than 3 years:—
    - (A) acquired after the medical laboratory technologist acquired such qualification; and
    - (B) recognized for the purposes of this specification by the Board; or
  - (ii) such other experience, acquired before the medical laboratory technologist obtained such qualification, as may be accepted by the Board in a particular case subject to such conditions (if any) relating to the acquisition of post qualification experience as the Board may impose.

in Part I of the register;

- (b) who holds a qualification referred as:—
  - (i) (4), (5), (6), (7), (8), (9) or (10) of this Notice but without the experience referred to in item a(i) or a(ii) of this Notice; or
  - (ii) (1), (2), (3) or (11) of this Notice,

in Part II of the register.

Applications for full registration should be made in accordance with the guidelines published by the Board and Council.
