Pursuant to section 16(2) of the Supplementary Medical Professions Ordinance (Cap. 359), an annual practising certificate will be issued to you <u>subject to the payment of the prescribed</u> fee for the issue of a practising certificate and your submission of a declaration stating whether or not you have been convicted in Hong Kong or elsewhere of any offence punishable with imprisonment since the date of the last declaration made by you for the purposes of your registration as an optometrist or application for a practising certificate. You must make such declaration if you wish to apply for an annual practising certificate for the year of 2024/25.

Separately, you are required to declare your CPD attainment in this declaration. With effect from 1 July 2021, the Optometrists Board has implemented the Mandatory Continuing Professional Development ("CPD") Scheme. <u>All</u> optometrists are required to acquire the necessary <u>CPD</u> <u>points</u> in accordance with the Manual for CPD Scheme for registered optometrists. The requirements of CPD points for the current 3-year cycle running from 1 July 2021 to 30 June 2024 are:

- Optometrists registered on/before 1 July 2021: 30 CPD points
- Optometrists registered between 2 July 2021 to 1 July 2022 (both dates inclusive):
 20 CPD points
- Optometrists registered between 2 July 2022 to 1 July 2023 (both dates inclusive): 10 CPD points
- Optometrists registered between 2 July 2023 to 30 June 2024 (both dates inclusive): 0 CPD points

Although the CPD attainment is <u>not</u> yet one of the conditions for renewing the practising certificate, any failure to make such declaration or to comply with the CPD requirement may be deemed as a contravention to section 1.3 in Part III of the Code of Practice which may lead to disciplinary proceedings.
