To safeguard public health and maintain the professionalism of occupational therapists, the Occupational Therapists Board ("the Board") has decided to adopt the following criteria with effect from 8 December 2023 –

(a) In line with the implementation of the Mandatory Continuing Professional Development ("CPD") scheme for the registered occupational therapists, applicants should have obtained the required CPD credit points, as follows-

Period of Removal	CPD credit point requirement [Note: the CPD credit points should be obtained during the period of removal and within 3 years immediately preceding the restoration application]
1 year or less	15
More than 1 year up to 2 years	30
More than 2 years	45

- (b) The CPD credit points should be recognized or accredited by the Board. For details on recognized CPD activities, please refer to the Manual of CPD for Registered Occupational Therapists at the website of the Board at: https://www.smp-council.org.hk/ot/en/content.php?page=cpd.

Applicants should complete the application form as attached, accompanied by a statutory declaration made before a Commissioner for Oaths or Notary Public as to the truthfulness of the contents of the application form.
